#### **Gender Identity Clinics Included in this Report**

#### **England**

There are seven adult GICs in England. They are all commissioned by NHS England and accept referrals from any patients who is registered with a GP in England.

- Charing Cross in London run by West London Mental Health NHS Trust
- Leeds GIC run by Leeds and York Partnership NHS Foundation Trust
- Northamptonshire Gender Dysphoria Service in Daventry run by Northamptonshire Healthcare NHS Foundation Trust
- Northern Region Gender Dysphoria Service in Newcastle run by Northumberland, Tyne and Wear NHS Foundation Trust
- Nottingham Centre for Gender Dysphoria run by Nottinghamshire Healthcare NHS Foundation Trust
- Porterbrook Clinic in Sheffield run by Sheffield Health and Social Care NHS Foundation Trust
- West of England Specialist GIC (previously known as The Laurels) in Exeter run by Devon Partnership NHS Trust

The **Tavistock GIDS** for children and adolescents is run by Tavistock and Portman NHS Foundation Trust. They are based in London but run satellite clinics in Exeter and Leeds.

#### Northern Ireland

There is only one adult GIC in Northern Ireland which is the **Brackenburn Clinic in Belfast** run by Belfast Health and Social Care Trust. It accepts referrals from throughout Northern Ireland.

There is also **Knowing Our Identity (KOI) in Belfast** which is the children and adolescents GIDS for Northern Ireland which is also run by Belfast Health and Social Care Trust.

#### **Scotland**

There are four adult GICs in Scotland. Most of them only accept referrals from certain parts of Scotland.

- Sandyford Clinic in Glasgow run by NHS Greater Glasgow and Clyde accepts referrals from throughout Scotland
- Aberdeen Clinic run by NHS Grampian only accepts referrals from patients in the NHS Grampian area
- Inverness Clinic run by NHS Highland only accepts patients from the NHS Highland area
- Chalmers Clinic in Edinburgh run by NHS Lothian only accepts patients from the NHS Lothian and NHS Borders areas

The Sandyford GIDS for children and adolescents is also run by NHS Greater Glasgow and Clyde.

#### Wales

Wales does not currently have its own GIC. All adult patients in Wales are referred to Charing Cross in London. They are not able to choose an alternative GIC.

### First Appointments at GIC

We asked how many patients had their first appointment with the GIC in the three months.

This isn't a valid exemption under the FOI (Scotland) Act and we are currently pursuing an internal review.

#### Time Waited for First Appointment at GIC

We also asked how long on average those patients who had a first appointment between August and October had been waiting for their appointment since they were referred. While this tells us the waiting time for those currently reaching the end of waiting list, it is not necessarily an accurate prediction for those who are just joining the list.

<sup>\*\*</sup>Tavistock said: "Up until recently it would have been no longer than 18 weeks. This year we have seen an unpredicted 100% increase in referrals and so it is likely to be longer than this for some referrals. We are actively working to develop a plan to address this issue."

<sup>\*\*\*</sup>Newcastle said: "As we have been given additional funding and have to recruit there are too many variables which impact on the potential waiting time of a new referral today. Therefore, any estimate would be little more than a guess."

<sup>\*\*\*\*</sup>Last quarter we collected this information by telephone, but were unable to get hold of these three clinics.

#### **Patients Who Have Waited Over 18 Weeks**

Referral to Treatment (RTT) standards in both England state that patients should receive treatment within 18 weeks of referral. We therefore asked each GIC how many of the people on their waiting list had been waiting for over 18 weeks.

#### **England Only - Referral to Treatment Time Reporting**

Every month, NHS England publish NHS-wide statistics on Referral to Treatment waiting times. It was over a year ago that NHS England confirmed the Referral to Treatment rules apply fully to gender identity services, so GICs and surgical providers should be sending their waiting times data to NHS England as part of this. We asked the seven adult clinics if they were doing so:

- Charing Cross, London: "Currently there is not a requirement to provide waiting time information to NHS England."
- Leeds Clinic: "No, we do not submit formal RTT times, as it has previously agreed by monitoring authorities that this target measure is not applicable to our services. However, regular updates regarding all aspects of the GIC service are reported to our Commissioners, and the GIC service is currently working alongside NHS England to reduce GIC waiting times."
- Northern Region Gender Dysphoria Service, Newcastle: "We do not include GIC waiting time information in the trust-wide RTT data submission as the Trust has never classed the gender service as meeting the national definition of a service in scope for the RTT reporting requirements. Waiting-times data for the GIC service is, however, regularly reported to NHS England local area commissioning team."
- Northamptonshire Gender Dysphoria Service, Daventry: "No as not a consultant-led service."
- Nottingham Centre for Gender Dysphoria: "Yes this information is included."
- **Porterbrook Clinic, Sheffield**: "We provide the referral to assessment waiting times to NHS England. They have not asked for us to provide the referral to treatment waiting times."
- West of England Specialist GIC (The Laurels), Exeter: "No we do not supply the 'GIC waiting time information in the trustwide RTT data that we send to NHS England'. This is because NHS England does not ask for this information. They asked a waiting time question in 2014/2015 (financial year) but this has been removed and is no longer a requirement in this reporting year (2015/2016)."

The answers provided here are quite concerning. Several of the clinics are still claiming to be exempt from the legal right to treatment (RTT) within 18 weeks, despite <a href="NHS England confirming that it does indeed apply">NHS England confirming that it does indeed apply</a>. In addition the vast majority of clinics are not providing the information to NHS England for their monthly NHS-wide updates.

According to NHS England's official statistics, as of the end of October 2015 there were 867 patients who the RTT rules apply to across the whole of the English NHS who had been waiting for an appointment longer than 52 weeks. However, we know from the data in this report that 637 patients in England have been waiting more than 52 weeks just for a first appointment at a gender clinic (and even more will have been waiting at least 52 weeks for actual treatment). These figures are <u>quoted in national</u> media and have even been <u>quoted by the Prime Minister</u>. Considering the inclusion of gender identity services (including surgeries, if they are not already included) would likely double this statistic we feel this is a serious omission and would urge NHS England to remedy the situation as soon as possible.
